Selectboard Meeting Minutes  
Feb 10, 2014

In attendance: David Stevens, Chair, Burton Hinton and Bill Perkins, Selectmen, Greg Gallagher, Town Clerk, Chris Evans, Lister, Vince and Louisa Dotoli and Gerald Saindon.

David called the meeting to order at 6:00 PM.

Bill moved and David seconded to add the following to the agenda:

- Transfer/NEKWMD sign
- Overlook LN update
- Landfill

Passed.

Burton reported that Steve thinks the International is fixed.

Bill moved and David seconded to approve the Jan 27<sup>th</sup>, Jan 29<sup>th</sup> and Jan 30<sup>th</sup>/Feb 1<sup>st</sup> Minutes. Passed.

Listers: Chris reported on the PV&R response to their appeal of the Equalization Study. One out of the three appeals was accepted by the State. Chris said that after the reappraisal all would be back to normal anyway. Burton moved and Bill seconded to sign off on the revised Equalization Study. Passed.

Burton moved and David seconded to approve Select Orders and Payroll #3. Passed.

David moved and Bill seconded to ask Greg to contact the Sheriff to allocate 2.75 hours per week for 10/1-5/22 and 19.75 hours per week for 5/23-9/30.

The Board will have Steve mount the new Transfer Station/NEKWMD sign on the scale shed.

David wondered what was being done about the States wishes to continue testing the closed Landfill site. Greg will contact Paul Tomasi, NEKWMD, about his negotiations with the state and ask him to use Aquaterra's letter for another reason not to have to continue testing.

Bill reported his conversation with Brian Monaghan in which Mr. Monaghan said he would draft a proposal of what to do with Overlook LN.

Bill read an e-mail from Sara Davies Coe, Tax Sale Attorney, in which she advised not to sell the Dunbat trailer at the upcoming tax sale.

Burton moved and Bill seconded that, under the advice of their Tax Sale attorney, not to put the Dunbar trailer up for tax sale. Passed.

The board decided not to call the land owner where the trailer sits until discussing in more detail with Sara.

Burton moved and Bill seconded to authorize the Chair to sign Excess Weight Permits for Newport Sand and Gravel, RG Gosnell and Clem-Dee. Passed.

The Board reviewed correspondence. They asked Greg to look for the court decision on Arcadia LN. If not available he can ask Bill May for it.

Bill moved and Burton seconded to adjourn at 7:53. Passed.
