Selectboard Meeting Minutes
Dec. 29, 2014

In attendance: Bill Perkins, Chair, Burton Hinton and David Stevens, Selectmen, Greg Gallagher, Town Clerk, Chris Evans, Gerald Saindon, Listers, Mariam Simonds and Erik Swanson.

Bill called the meeting to order at 6:00.

Burton moved and David seconded to add the following to the Agenda:

She also reported receipt of the state's "Equalization Study" The COD is 15.35% and the CLA is 94.65%. These numbers will change after completion of the new Re-Appraisal.

Erik, Delinquent Tax Collector, talked about an upcoming Tax Sale as well as moving the Sale to after six months of delinquency. The Board had no problem with that.

Greg presented a barking dog complaint from Wally Rogers. Mariam said it was not a problem with other neighbors. After debating what action the Board should take, Burton moved and David seconded for Greg to report this to Kathleen, the Deputy Animal Control Officer to visit the owners of the dog(s) to explain the Ordinance. Passed.

Greg updated the Board with garbage sticker prices and an analysis of cost by Paul Tomasi. Other discussion followed.

Greg presented a proposed 2015 Selectboard Meeting Schedule.

Burton moved and David seconded to accept the 2015 Selectboard Meeting Schedule. Passed.

Pay raises were brought up. David said what is passed by the voters at Town Meeting is what it is. Bill asked what the different rates for different health plans are. Greg said the "enrollment period" is closed. We have to stick with the health policies we have now.

The Board will review this issue in the "Personnel Policy at the next meeting.

David moved and Bill seconded to approve Select Orders #1A, bills due after Jan 1, but to be paid this week. Passed.


