- They also asked the Board to think about banning large items from the Construction container. Someone recently dropped off a hot tub. The Board thought it would not be good to ban such items because they would then appear on the road side. The Board will review this at Budget Meetings.
- Mariam listed off many recycling things that Casella would not take that NEKWMD still takes.
- Amanda left a list of comments/concerns. The Board asked Greg to give it to the Road Crew.
