Additions to Agenda

Bill moved and David seconded to add the following to the agenda. Passed.

Road Foreman Report

- Clayton addressed Overlook Ln washout/culvert plugged, he will work on that tomorrow.
- Hole on Abbott Rd / Newark side - they were working on that today.
- Big Valley grant work will be completed by May.
- Norman wants to know if he can finish Hinton Hill Rd work for us - response: Contract good till project is finished.
- Gravel Pit - no decisions to make yet we need a copy of what they pay for crushing. David would like to know how much gravel is taken out and how much is left.
- Town Garage working on Long Pond Rd with grader
- Peene Hill to Cook Rd work - Clayton request quotes for the road work including specific time frame for work to be completed.
- Street lights - Clayton will verify how many street lights are out and call Barton Electric. He will also contact Vermont Efficiency for lighting options.

- C & D Analysis - does the analysis provided include hauling for recyclables? What is the hauling fee for recycling?
- David moved and Bill seconded to increase C & D per pound to 0.17 beginning May 1, 2018. Passed.
- Municipal Bldg painting - Bill looked at Municipal Bldg and observed one section with damage. David moved and Peter Seconded to place an ad in the Chronicle for bids to paint the building. Passed.
