Road Foreman Report

- Sarah Damsell from the Orleans Country Conservation District discussed the site visit she had with Clayton last week and the submission of a grant application for Lakeview Road which is due October 26th. This is the area near the Lidback farm regarding gully erosion that is happening.
- Clatyon reported a new culvert was installed on Blueberry Point Lane
- The 1 ton will need new tires. Estimated to be \$190 per tire totaling around \$760.
- The International repairs are finished and everything was covered under warranty.
- A ditch was re-stoned on Long Pond
- Paving – Peene Hill/Cooks road. Discussion occurred and a special SB meeting will be held on Thursday at noon to do a site visit.
- Gravel – Bill spoke to Mark Ellingwood, Newark SB member. They haven't crushed any gravel yet, but they plan to soon.

Local Citizens

- Bill reported that Heritage Memorials cleaned the tombstones at the cemetery. They did a great job and look fantastic.

Transfer Station

- Casella letter with pricing – This was given to the board, no action taken. Discussion occurred about having a special SB meeting during the day to discuss trash/recycling pick up for next year considering Jim will not be renewing his contract. Possibly early October for a meeting to start reviewing this.

Old Business

- RCT Letter from Frank Maloney – Bill read the letter from Frank Maloney out loud. Glen has resigned from his director's seat. Westmore has the option to give our seat to another Orleans County municipality for the remainder of the term or we can appoint another representative to fulfill Glen's term which ends July 2021. Glen hopes we can retain our seat. Anyone that is interested can reach out to a Selectboard member or Glen.

- Sherri from Audiocarve – presented information about the new 1st Responders network FirstNET and how the plans work. More information is available at the town clerk's office.
- Raymond Rodrigue – Orleans Snow Stormer's. Requesting permission to maintain, cross and groom trails in the Town of Westmore along with permission to debrush a portion of Perkins Lane used as snowmobile trail. David moved and Peter seconded to have Bill sign the permission form. Passed.
